#### SUGGESTED DIRECTIONS

**RESURGE™** can be applied to all crops including: vegetable crops, row crops, field crops, manure lagoons/pits, trees and vines.

Apply 11.2 - 44.8 kg/ha per year. May be applied anytime during the year. First preference would be to broadcast in the fall after deep tillage. Second preference is to broadcast pre-plant up to first blossom.
